**\*\* EARLY DISMISSAL/LATE ARRIVAL RULES \*\***

Early dismissal/late arrival pass is a privilege – not a right!! It can be revoked at any time. In order to qualify for an early dismissal/late arrival pass, a student must qualify according to the following criteria:

- ✓ Must be a senior.
- ✓ Must be in good academic standing.
- ✓ Must have passed all **REQUIRED** Regents Exams for graduation and does not **REQUIRE** AIS (Academic Intervention Services).

You may apply with this form up to August 15<sup>th</sup>, however if you apply before the end of the current school year (June 24<sup>th</sup>), there **MAY** be a better chance that your schedule can be adjusted. Drop off completed forms to your counselor's office before July 1 or you can leave it at the Main Office before August 15th. There is **NO** guarantee that your schedule can be adjusted to allow early dismissal. Counselors will try their best; however, the courses you need may not fit the schedule you want!

Students must exit by the security desk and be ready to show their schedule showing early dismissal or late arrival. Any attempts to alter or deface the schedule may result in the loss of the early dismissal privileges. Students who fail to leave the premises at the above stated time must report to their Dean or Principal for assignment to a study hall. Violators will jeopardize their early dismissal status. For late arrival, all students must sign in with their attendance office. In the event of a 1-2 hour delay, students must stay to the end of their class. This applies even if it goes past your dismissal time.
